2018 APPLICATION FOR PRIVATE POOL GUIDELINES

\$200.00: 2 hour rental with 25 guests or less; \$80.00 for each additional hour.
Includes two (2) lifeguards.

\$250.00: 2 hour rental with 26 guests or more, \$100.00 for each additional hour.
Includes four (4) lifeguards.

PRIVATE PARTY HOURS

The Swimming Pool of Avalon Park is available for pool parties outside of the regular pool hours:

MONDAY thru FRIDAY	8:00 – 10:00 p.m.
SATURDAY & SUNDAY	6:30 – 8:30 p.m.

By executing this Application, the Applicant agrees to the following:

1. All Private Pool Parties require a minimum of two (2) lifeguards. There are no exceptions to this requirement. Parties with twenty-six (26) guests or more require a minimum of four (4) lifeguards. More lifeguards may be required for larger parties.
2. Payment for the Private Pool party must be received by the Borough Administrative Office in full at least one (1) week prior to the private pool party. This amount does not include the refundable security deposit described below.
3. A \$100.00 refundable security deposit is required at the time the Private Pool Party is booked to reserve the date, along with a completed application. (Cash or check only. Make checks payable to "Borough of Avalon"). This amount will be returned if you cancel the Private Pool Party at least one (1) week prior to the scheduled date. Security deposit will be assessed in the event of extended hours,

late clean up, damage to Borough property, failure to adequately clean pool area, or other good cause. The Borough may assess additional amounts for the same. Security deposits, or balances thereof, will be approved at the next Council meeting following the private party and returned to the Applicant at the mailing address noted on the application. A copy of a valid driver's license or photo ID must be attached with the application.

4. Party setup is 15 minutes before your party begins. For example, 7:45 pm for an 8:00 pm party; 6:15 pm for a 6:30 pm party. A \$25.00 fee will be assessed if you do not exit the Pool within (15) fifteen minutes after the scheduled completion of your Private Pool Party.
5. Due to the popularity of our Private Pool Parties, we cannot accommodate alternative dates (i.e., we will not schedule your Private Pool Party for one date and then "hold" an alternative date).
6. All attendees must comply with the Pool Rules and the directions of the Pool Manager and lifeguards.
7. Applicant is responsible for the set-up and clean-up of the event. It is the responsibility of the applicant to supervise all guests. The applicant will be held personally liable for their group's actions, including any damages, losses or rule violations by his/her/their guests. Guests and/or Applicants who violate any Pool Rule and/or the directions of the Pool Manager or lifeguards may be directed to leave the Private Pool Party immediately. Failure to do so may require the assistance of Borough Police.
8. **Alcohol is expressly prohibited in the Park and Pool.** For safety reasons, no grills are permitted in the pool area. For a list of other pool rules, please contact the Borough Administration Office.
9. We strongly suggest that you have an alternative plan in case inclement weather forces you to cancel your Private Pool Party. If inclement weather is predicted, you must make a decision on whether to hold your Private Pool Party by 6:00 PM on the night of the Private Pool Party. Once you inform us of this decision by contacting the Pool and speaking with the Pool Manager or emailing the manger at Poolmgr@boroughofavalon.org, the decision is final. However, once your party begins, we cannot refund your payment.
10. Park shelters can also be rented for your event. Contact the Borough Administration Office for shelter rental rates and scheduling.
11. The Borough withholds the right to deny any Application for Private Pool Party based upon Applicant's past failures to comply with pool rules, failure to pay required amounts, failure to complete application or other good cause.
12. Pool rules and regulations are subject to change without advanced notice to Applicant.
