Clean-up Meeting

Meeting reconvened from the December 18, 2012 meeting by President Repp at 7:05.

Public Comment:

Chief Mike Adams of the Emsworth Fire Department addressed the snow removal on Locust Avenue in Emsworth. The fire truck entrance is on that street and the Avalon DPW is responsible for salting and plowing that section of state road. He was concerned over making sure it is hit in a timely fashion and that the clean-up trucks went the wrong way on a one way street during yesterdays storm. He was

concerned over safety in using that method. Dilmore stated that it would be corrected and that his concerns were founded. That the DPW would be made aware that they must go in proper direction when plowing. Adams wanted it on record that issue was brought to Councils attention.

Sattler stated that Council did hold an Executive Session on a personal issue reviewing applications on the hiring of a full time officer to

the Avalon Police Department. This was done in accordance with the Sunshine Act.

Narcisi:

Moved to appoint the successful candidate to fulltime status on the Avalon Police Department, contingent on the candidate passing the required physical, psychological, and credit checks. Have the Secretary notify all the candidates of their status after the interviews. Cortese 2<sup>nd</sup>, 8-0.
