ORDINANCE NO. 1105

AN ORDINANCE REGULATING THE NUMBER OF POLICEMEN AND POLICE OFFICERS WITHIN THE BOROUGH OF AVALON AND REGULATING THE SALARIES OF THE POLICEMEN AND POLICE OFFICERS WITHIN THE BOROUGH OF AVALON

BE IT ORDAINED AND ENACTED by the Council of the Borough of Avalon, and it is hereby ordained and enacted by the authority of the same:

SECTION I.

That effective January 1, 1977, the number of Policemen in the Borough of Avalon is hereby fixed at eleven (11) and their duties, positions and salaries shall be as follows:

(a). One (1) Chief of Police with general direction of the Police Department and subject to the statutory authority of the Mayor of Avalon, whose salary shall be as follows:

1. Effective January 1, 1977 to December 31, 1977, the sum of SIXTEEN THOUSAND FIVE HUNDRED SIXTY-FIVE and 50/100 (\$16,565.50) DOLLARS per year.
2. Effective January 1, 1978 to June 30, 1978, the sum of SEVENTEEN THOUSAND TWO HUNDRED SIXTY-FIVE and 50/100 (\$17,265.50) DOLLARS per year.
3. Effective July 1, 1978 to December 31, 1978, the sum of SEVENTEEN THOUSAND NINE HUNDRED FIFTEEN and 50/100 (\$17,915.50) DOLLARS per year.
4. The Chief of Police shall be entitled to longevity pay entitlement based upon ONE (\$1.00) DOLLAR per month for each year of service after five (5) years of continuous service.
 - (b). Three (3) Lieutenants of Police who shall perform duties as a Police Officer and shall be second in command to the Chief of Police, whose salaries shall be as follows:
 1. Effective January 1, 1977 to December 31, 1977,

2. Effective January 1, 1978 to June 30, 1978, the sum of FIFTEEN THOUSAND EIGHT HUNDRED SIXTEEN and 89/100 (\$15,816.89) DOLLARS per year.

3. Effective July 1, 1978 to December 31, 1978, the sum of SIXTEEN THOUSAND FOUR HUNDRED SIXTY-SIX and 89/100 (\$16,466.89) DOLLARS per year.

4. The Lieutenants of Police shall be entitled to longevity pay entitlement based upon ONE (\$1.00) DOLLAR per month for each year of service after five (5) years of continuous service.

(c). Seven (7) Patrolmen who shall perform the customary and ordinary duties of police subject to the orders of their immediate superiors; said Patrolmen divided into two (2) groups in respect to salaries as follows:

Group 1. Patrolmen of police force with more than six (6) months of service whose salaries shall be as follows:

1. Effective January 1, 1977 to December 31, 1977, the sum of THIRTEEN THOUSAND NINE HUNDRED SIX and 11/100 (\$13,906.11) DOLLARS per year.

2. Effective January 1, 1978 to June 30, 1978, the sum of FOURTEEN THOUSAND SIX HUNDRED SIX and 11/100 (\$14,606.11) DOLLARS per year.

3. Effective July 1, 1978 to December 31, 1978, the sum of FIFTEEN THOUSAND TWO HUNDRED FIFTY-SIX and 11/100 (\$15,256.11) DOLLARS per year.

4. Patrolmen of police force with more than six (6) months of service shall be entitled to longevity pay entitlement based upon ONE (\$1.00) DOLLAR per month for each year of service after five (5) years of continuous service.

Group 2. Patrolmen of police force with six (6)

months of service or less whose salaries shall be as follows:

2. Effective January 1, 1978 to June 30, 1978, the sum of TWELVE THOUSAND ONE HUNDRED FIFTY-NINE and 46/100 (\$12,159.46) DOLLARS per year.
3. Effective July 1, 1978 to December 31, 1978, the sum of TWELVE THOUSAND EIGHT HUNDRED NINE and 46/100 (\$12,809.46) DOLLARS per year.

SECTION II. That any Ordinance or part of Ordinance inconsistent or conflicting with the provisions of this Ordinance be and the same is hereby repealed.

THIS ORDINANCE ORDAINED AND ENACTED into a law in Council this 30TH day of December, 1976.
