ORDINANCE NO. 1168

AN ORDINANCE PROVIDING FOR THE PAYMENT OF AVALON BOROUGH TAXES ON REAL ESTATE IN INSTALLMENTS; FIXING THE DATES FOR THE PAYMENT OF SAID INSTALLMENTS AND THE DATES ON WHICH SAID TAXES SHALL BE DEEMED DELINQUENT; PROVIDING PENALTIES; AND REPEALING INCONSISTENT ORDINANCES.

THE COUNCIL OF THE BOROUGH OF AVALON HEREBY ORDAINS:

SECTION 1: That the taxpayers of the Borough of Avalon owing taxes on real estate for any tax year, may pay said taxes on real estate in four equal installments .

SECTION 2: That the said installments and dates on which same shall be paid be as follows:

25% of the face amount of the tax shall be due and payable on or before June 30 of each specific tax year;

25% of the face amount of the tax shall be due and payable on or before August³¹ of each specific tax year;

25% of the face amount of the tax shall be due and payable on or before October 31 of each specific tax year;

25% of the face amount of the tax shall be due and payable on or before December 30 of each specific tax year.

If any installment is not paid on the dates aforesaid, such installment shall be deemed to be delinquent.

SECTION 3: Payment of said installments if made prior to the date of delinquency shall be at the flat rate basis without abatement or discount, but to each installment upon the date on which it becomes delinquent a penalty of five (5%) percent shall be added, which shall be collected by the Tax Collector in accordance with the provisions in existing law.

SECTION 5: Where a taxpayer shall fail to evidence an intention to pay on the installment plan as hereinbefore provided, his, her or its taxes shall become due and payable and shall be collected in the manner provided for by Act 394 of 1945, as amended, subject to the discounts and penalties provided by said Act.

SECTION 6: This Ordinance fixing installment dates shall become effective January 1, 1978 and shall continue in effect for each and every tax year for Avalon Borough Real Estate Taxes until such time as it is repealed or amended by the Council of the Borough of Avalon.

SECTION 7: That the method of collecting taxes by installments as herein provided shall be in addition to any method hereinbefore or hereafter provided by law for the collection of real estate taxes.

SECTION 8: That any ordinance, or part thereof, conflicting with the provisions of this Ordinance be and the same is hereby repealed insofar as the same affects this Ordinance.
