ORDINANCE NO. 1137

AN ORDINANCE OF THE BOROUGH OF AVALON, AUTHORIZING THE PRESIDENT OF COUNCIL AND THE SECRETARY TO EXECUTE A MUTUAL COOPERATION AND ENFORCEMENT AGREEMENT WITH THE BOROUGH OF BELLEVUE AS TO THEIR RESPECTIVE POLICE DEPARTMENTS, WITH THE APPROVAL OF THEIR RESPECTIVE MAYORS.

WHEREAS, the Borough of Avalon is desirous of entering into a joint cooperation and enforcement agreement with the Borough of Bellevue as to their respective Police Departments; and

WHEREAS, the authority to execute such an agreement is vested in the Council of the Borough of Avalon; and

WHEREAS, the Council of the Borough of Avalon, with the approval of the Mayor of the Borough of Avalon and the recommendation of the Chief of Police, after due investigation and deliberation, has deemed it to be in the best interest of the citizens of the Borough of Avalon to authorize the Borough of Avalon Police Department to cooperate with the Borough of Bellevue Police Department in the enforcement of the laws of the Commonwealth of Pennsylvania and the respective ordinances of the Borough of Avalon and of the Borough of Bellevue.

NOW THEREFORE, THE COUNCIL OF THE BOROUGH OF AVALON HEREBY ORDAINS:

Section I: The officers of the Borough of Avalon Police Department are hereby authorized to cooperate with the officers of the Borough of Bellevue Police Department in the enforcement of the laws of the Commonwealth of Pennsylvania and the ordinances of the Borough of Avalon and of the Borough of Bellevue.

Section II: The Council of the Borough of Avalon, with the approval of the Mayor of the Borough of Avalon, hereby authorizes the President of Council and the Secretary of Council to execute an agreement setting forth the rights, duties and obligations of the officers of the Borough of Avalon Police Department and of the officers of the Borough of Bellevue Police Department.

Section III: The Council of the Borough of Avalon, with the approval of the Mayor of the Borough of Avalon, hereby directs that the agreement referred to herein shall in no way adversely affect the police coverage of the Borough of Avalon.


Section IV: Any ordinance, or part thereof, conflicting with the provisions of this ordinance is hereby repealed insofar as the same affects this ordinance.


