 ORDINANCE NO. 1152  
 AN ORDINANCE OF THE BOROUGH OF AVALON, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 1033, ADJUSTING THE SCHEDULE OF FEES, THE DEFINITION OF CRIBBING AND DELETING SECTION 513, SUNDAY WORK. BE IT ORDAINED AND ENACTED by the Council of the Borough of Avalon, and it is hereby ordained and enacted by and with the authority of the same as follows:

SECTION I: Article II, Item 3, Section 104.31, Fee: Schedule of Fees, shall be amended to read as follows:  
 Item 3, Section 104.31 Fees: The following schedule of fees shall be adopted:

Valuation of Work	Fees
\$1,000.00 to 3,000.00	\$10.00
\$3,001.00 to 7,500.00	\$15.00
\$7,501.00 to 10,000.00	\$20.00
\$10,001.00 to 15,000.00	\$30.00
\$15,001.00 to 20,000.00	\$35.00
\$20,001.00 to 30,000.00	\$50.00
\$30,001.00 to 40,000.00	\$65.00
\$40,001.00 to 50,000.00	\$80.00
Over \$50,000.00	\$80.00 plus \$2.00 per \$1,000.00 or fraction thereof on the estimated cost in excess of \$50,000.00. There will be an additional cost for special technical services.

SECTION II: Article V, Section 504 entitled CRIBBING shall be amended to read as follows:  
 Article V, Section 504 CRIBBING: When cribbing is used as a type of construction for retaining walls, the material used must have its exposed surface earth covered and seeded to prevent erosion. No retaining walls shall be constructed of wood cribbing. The only exception to the above shall be railroad ties or properly treated wood, which will withstand the weather and rot as acceptable construction materials properly treated.

SECTION III: Article V, Section 513 entitled Sunday Work shall be deleted from Ordinance No. 1033 as originally set forth.

SECTION IV: Article V, Section 513, Sunday Work shall be replaced with the following section:  
 "Article V, Section 513, Resident/property owners of the Borough of Avalon shall be entitled to replace existing parts of said building structures with a similar replacement so as to maintain building in its same condition without permitting structural changes in the building, i.e., permitting the property to be maintained by replacing roof, doors, and windows, with like and equal roof, doors, or windows. Such changes necessary to require a building permit to be issued. The plans for work to be done must be submitted to the building inspector for determination as to whether a building permit shall be required."

SECTION V: Any ordinance or part of ordinance in conflict with this Ordinance shall be and is hereby repealed to the extent of conflict to give this Ordinance full force and effect.
