ORDINANCE NO. 115.3

AN ORDINANCE REGULATING THE SALARIES OF THE POLICEMEN AND POLICE OFFICERS OF THE BOROUGH OF AVALON AND REPEALING ANY AND ALL OF THE BOROUGH OF AVALON ORDINANCES REGULATING THE NUMBER OF POLICE AND POLICE OFFICERS.

BE IT ORDAINED AND ENACTED by the Council of the Borough of Avalon, and it is hereby ordained and enacted by and with the authority of the same:

SECTION I: Effective January 1, 1983, the Borough of Avalon shall fix the salaries of police and police officers for the calendar year January 1, 1983 to December 31, 1983 and from January 1, 1984 to December 31, 1984 as follows:

A. CHIEF OF POLICE

- 1. Effective January 1, 1983 to March 31, 1983, the Chief of Police shall be paid the sum of \$2,040.33 per month.
- 2. Effective April 1, 1983 to December 31, 1983, the Chief of Police shall be paid the sum of \$2,162.55 per month.
- 3. Effective January 1, 1984 to December 31, 1984, the Chief of Police shall be paid the sum of \$2,242.00.

B. LIEUTENANTS

- 1. Effective January 1, 1983 to March 31, 1983, lieutenants shall be paid the sum of \$1,875.40 per month.
- 2. Effective April 1, 1983 to December 31, 1983, lieutenants shall be paid the sum of \$1,997.60 per month.
- 3. Effective January 1, 1984 to December 31, 1984, lieutenants shall be paid the sum of \$2,077.03 per month.

C. SARGEANTS

- 1. Effective January 1, 1983 to March 31, 1983, sargeants shall be paid the sum of \$1,806.45 per month.
- 2. Effective April 1, 1983 to December 31, 1983, sargeants shall be paid the sum of \$1,928.67 per month.
- 3. Effective January 1, 1984 to December 31, 1984, sargeants shall be paid the sum of \$2,008.12 per month.

D. PATROLMEN WITH MORE THAN SIX MONTHS SERVICE

- 1. Effective January 1, 1983 to March 31, 1983, patrolmen shall be paid the sum of \$1,737.50 per month.
- 2. Effective April 1, 1983 to December 31, 1983, patrolmen shall be paid the sum of \$1,859.72 per month.
- 3. Effective January 1, 1984 to December 31, 1984, patrolmen shall be paid the sum of \$1,939.16 per month.

E. PATROLMEN WITH LESS THAN SIX MONTHS SERVICE

- 1. Effective January 1, 1983 to March 31, 1983, patrolmen shall be paid the sum of \$1,458.85 per month.
- 2. Effective April 1, 1983 to December 31, 1983, patrolmen shall be paid the sum of \$1,581.07 per month.
- 3. Effective January 1, 1984 to December 31, 1984, patrolmen shall be paid the sum of \$1,660.51 per month.

SECTION II: Any Ordinance or part of Ordinance inconsistent or conflicting with the provisions of this Ordinance be and the same is hereby repealed.
