ORDINANCE NO. 1167

AN ORDINANCE OF THE BOROUGH OF AVALON, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, AMENDING SECTION 4 OF ORDINANCE NO. 834 AND ALSO SECTION 2 OF ORDINANCE NO. 1102 OF THE BOROUGH OF AVALON BY AMENDING THE PARKING HOURS, PARKING FEES.

Be it ordained and enacted by the Council of the Borough of Avalon, and it is hereby ordained and enacted by and with the authority of the same as follows:

Section 1: Section 4 of Ordinance No. 834, also known as Section 2 of Ordinance No. 1102, shall be amended to read as follows:

"Section 4: In order that Police Officers or persons designated by Borough Council to patrol meters may properly compute the time during which a vehicle is parked, the owner or operator of said vehicle shall, upon entering such parking space, during the time of limited parking, immediately deposit a five cent (\$.05) coin, a ten cent (\$.10) coin, a twenty-five cent (\$.25) coin of the United States in the Parking Meter situated at the side of said parking space, and operate the timing mechanism of the Parking Meter according to instructions thereon.

Only one hour of time will be registered on the Parking Meter. Parking Meters shall include instructions as follows:

10 MINUTES FOR EACH NICKEL  
20 MINUTES FOR EACH DIME  
1 HOUR FOR EACH QUARTER  
TO MAXIMUM TIME ON DIAL


Failure to operate the meter shall constitute a violation of this ordinance. Upon the deposit of such coinage, and placing the meter in operation, the parking space may be lawfully occupied by such vehicle during the period of time which has been prescribed for the particular amount deposited. The Parking Meters, when properly operated, shall be so adjusted that coins may be deposited

at any time throughout the marked range of the meters and the lawful time availability restored to the maximum period of sixty (60) minutes. If such vehicle shall remain parked in any such parking space for such length of time that the meter shall indicate by a proper signal that the lawful parking period has expired, such vehicle shall be considered as parking overtime, and the parking of a vehicle overtime shall be a violation of this ordinance."


Section 2: Any Ordinance or part of any Ordinance inconsistent or conflicting with the provisions of this Ordinance be and the same is hereby repealed.

This Ordinance ordained and enacted into Law in Council this 18<sup>th</sup> day of March, 1986.


