

BOROUGH OF AVALON
ORDINANCE NO. 1253

AN ORDINANCE OF THE BOROUGH OF AVALON, COUNTY OF ALLEGHENY AND COMMONWEALTH OF PENNSYLVANIA, PROHIBITING THE RIDING, PROPELLING OR OPERATION OF SKATEBOARDS, ROLLER SKATES, ROLLER BLADES AND SCOOTERS ON CALIFORNIA AVENUE IN THE BOROUGH OF AVALON AND ON THE SIDEWALKS ADJACENT THERETO; PROHIBITING THE RIDING, PROPELLING OR OPERATION OF BICYCLES ON THE SIDEWALKS ADJACENT TO CALIFORNIA AVENUE WITHIN THE BOROUGH OF AVALON; PROHIBITING THE RIDING, PROPELLING OR OPERATION OF SKATEBOARDS AND BICYCLES IN THE CALIFORNIA AVENUE MINI-PARK AND THE BIRMINGHAM AVENUE TOT-PARKS; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; AND REPEALING ALL INCONSISTENT ORDINANCES.

SECTION 1: ENACTING CLAUSE

Be it ordained and enacted by Council of the Borough of Avalon; and it is hereby ordained and enacted by the authority of the same, that from and after the effective date of this Ordinance, the following Ordinance shall be in full force and effect in the Borough of Avalon.

SECTION 2: SHORT TITLE

This Ordinance shall be known as the Borough of Avalon Skateboard and Bicycle Ordinance.

SECTION 3: CONFLICT AND REPEALER OF OTHER ORDINANCES

Any ordinance, or part thereof, conflicting with the provisions of this ordinance is hereby repealed insofar as the same affects this ordinance.

SECTION 4: PROHIBITED ACTS FOR SKATEBOARDS, SCOOTERS, ROLLER SKATES AND ROLLER BLADES ON CALIFORNIA AVENUE OR SIDEWALKS ADJACENT THERETO

No person shall ride, propel or operate a skateboard, scooter, roller skates or roller blades on California Avenue or on the sidewalks adjacent thereto within the Borough of Avalon.

SECTION 5: PROHIBITED ACTS FOR BICYCLES ON SIDEWALKS ADJACENT TO CALIFORNIA AVENUE

No person shall ride, propel or operate a bicycle on the sidewalks adjacent to California Avenue within the Borough of Avalon.

SECTION 6: PROHIBITED ACTS FOR SKATEBOARDS AND BICYCLES IN THE CALIFORNIA AVENUE MINI-PARK AND THE BIRMINGHAM AVENUE TOT-PARKS

No person shall ride, propel or operate a skateboard or a bicycle in the California Avenue mini-park or in the Birmingham Avenue tot-parks in the Borough of Avalon.

SECTION 7: PENALTY FOR VIOLATIONS

Any person violating any provision of this ordinance shall, upon conviction, be fined \$25.00 plus costs for the first offense. Any person violating any provision of this ordinance for the second and/or subsequent time shall, upon conviction, be fined not less than \$35.00 nor more than \$100.00 plus costs. Upon default of payment under this section, the person may be sentenced to a period of imprisonment not to exceed ten (10) days.
