

**BOROUGH OF AVALON  
ORDINANCE NO. 1301**

**ORDINANCE OF THE BOROUGH OF AVALON, AUTHORIZING CERTAIN POLICE OFFICERS OF THE BOROUGH OF BELLEVUE TO ENTER INTO THE BOROUGH OF AVALON FOR THE PURPOSE OF ENFORCING LAWS OF THE COMMONWEALTH OF PENNSYLVANIA AND ORDINANCES OF THE BOROUGH OF AVALON AND BOROUGH OF BELLEVUE.**

**WHEREAS, on March 3, 1980, an agreement was entered into between the Borough of Avalon and the Borough of Bellevue, authorizing the Police Departments of both Boroughs to cooperate with each other in the enforcement of the laws of the Commonwealth of Pennsylvania, and the respective ordinances of the Borough of Bellevue and the Borough of Avalon; and**

**WHEREAS, said agreement authorized the police officers of each Borough to enter the territory of the other for the aforesaid purpose; and**

**WHEREAS, said agreement was approved by the respective Councils and Mayors of said Boroughs.**

**NOW THEREFORE, THE COUNCIL OF THE BOROUGH OF AVALON HEREBY ORDAINS:**

**SECTION 1: The following members of the Borough of Bellevue Police Department are hereby authorized to exercise police powers in conformance with ordinances heretofore enacted and the agreement dated March 3, 1980 by and between the Borough of Avalon and the Borough of Bellevue, which by reference thereto is incorporated herein.**


