**RESOLUTION NO. 1058**

**A RESOLUTION OF THE BOROUGH OF AVALON, COUNTY OF ALLEGHENY, AUTHORIZING ITS CITIZENS TO PAY THEIR EARNED INCOME TAXES (EIT), THE LOCAL SERVICES TAX (LST), THE AVALON REAL ESTATE TAX, AND ANY AND ALL ADMINISTRATIVE PAYMENTS MADE TO THE BOROUGH, INCLUDING BUT NOT LIMITED TO FEES FOR GARBAGE PICK UP, SEWAGE, AND PARKS AND RECREATION.**

**WHEREAS**, the Borough of Avalon has established its own website at [www.boroughofavalon.org](http://www.boroughofavalon.org) for the use and benefit of its citizens and general public;

**WHEREAS**, the Borough of Avalon desires to have its citizens utilize this website, not only for their enjoyment but also for their administrative convenience;

**WHEREAS**, the Borough of Avalon believes that providing its citizens with the option of making certain payments on the Borough's website would be deemed convenient by at least some of its citizens; and

**WHEREAS**, the Borough of Avalon has agreed to designate specific items which its citizens may, at their option, pay on the website if they so desire.

**NOW, THEREFORE, BE IT RESOLVED** in order to further the purposes set forth by this Resolution, the Borough of Avalon herein declares as follows:

**SECTION 1.** Beginning on May 1, 2010, Avalon's citizens **may, at their discretion**, pay the following items through the Borough's website: [www.boroughofavalon.org](http://www.boroughofavalon.org):


- a. Earned Income Taxes (EIT);
- b. The Local Services Tax (LST);
- c. Avalon's Real Estate Taxes (but not Northgate's School Taxes); and
- d. Administrative Payments, including but not limited to fees for garbage pick up, sewage, and parks and recreation.

**SECTION 2.** This Resolution does **not** in any way require the Borough's citizens to make their payments through the website if they prefer to continue making their payments as they have done in the past, whether through the U.S. mail or in person.


