RESOLUTION NO. 857

A RESOLUTION OF THE BOROUGH OF AVALON, ALLEGHENY COUNTY, PENNSYLVANIA, APPOINTING INEZ L. STAUFFER AS THE COLLECTOR OF TAXES LEVIED AND ASSESSED PURSUANT TO THE AUTHORITY SET FORTH IN ACT 511, WHICH APPOINTMENT SHALL INCLUDE THE COLLECTION OF MERCANTILE TAXES AND OCCUPATIONAL PRIVILEGE TAXES LEVIED AND ASSESSED BY THE BOROUGH OF AVALON UPON RESIDENTS AND BUSINESSES OF THE BOROUGH OF AVALON. ALL SUCH APPOINTMENTS BEING FOR THE YEAR 1996, AND SETTING FORTH THE COMPENSATION FOR THE COLLECTION OF THE TAXES LEVIED AND ASSESSED PURSUANT TO ACT 511.

BE IT RESOLVED by the Council of the Borough of Avalon, Allegheny County, Pennsylvania, and it is hereby resolved by and with the authority of the same:

SECTION I. That Inez L. Stauffer, the elected Real Estate Tax Collector for the Borough of Avalon, is hereby appointed as the Collector of all taxes levied and assessed by the Borough of Avalon, including the collection of mercantile taxes and occupational privilege taxes levied and assessed by the Borough of Avalon upon residents and businesses of the Borough of Avalon; all such appointments being for the calendar year 1996.

SECTION II. That the compensation to be paid the elected Real Estate Tax Collector for the Borough of Avalon was established pursuant to the provisions of Resolution No. 664.

SECTION III. That Inez L. Stauffer, for the collection of the Borough of Avalon Act 511 taxes, shall receive from the Borough of Avalon as compensation therefore during the calendar year 1996 the following sums:

- A. Per Capita Tax - The sum of \$0.50 per tax bill mailed, payable at the estimated rate of \$185.00 per month;
- B. Earned Income Tax - 2½% of the collections of current earned income taxes, payable at the estimated rate of \$390.00 per month;
- C. All other Act 511 Taxes - 2½% of the collected amount, payable at the estimated rate of \$25.00 per month.

D. Delinquent Act 511 Taxes - 5% of such taxes collected.

SECTION IV. The Borough of Avalon, in addition to the compensation set forth herein, shall pay the said Inez L. Stauffer, one-half of the total expenses of printing, tax statements, tax forms, postage and envelopes for the calendar year 1996.

SECTION V. That the aforementioned Inez L. Stauffer shall be paid on a monthly basis by the Borough of Avalon the estimated monthly rates as hereinabove set forth. The Borough of Avalon shall and will during the month of July, 1996, and during the month of January, 1997, calculate the actual collections of the various taxes made by the said Inez L. Stauffer for the preceding six (6) months, and reserves the right to adjust the monthly estimated payments for the second half of the year in July, 1996.

SECTION VI. That the said Inez L. Stauffer shall perform the duties set forth herein, and the Borough of Avalon will withhold Federal, State Income Taxes and Social Security Taxes from the estimated payments made to Inez L. Stauffer on a bimonthly basis pursuant to the provisions of this Resolution.

SECTION VII. That any Resolution or part of any other Resolution conflicting with the provisions of this Resolution be and the same are hereby repealed to the extent of such conflict.
