RESOLUTION NO. 1063

A RESOLUTION OF THE BOROUGH OF AVALON, COUNTY OF ALLEGHENY, AUTHORIZING THE PARENT TEACHER ORGANIZATION OF AVALON ELEMENTARY TO ISSUE PARKING PERMITS FOR DESIGNATED SPACES BETWEEN NORTH SCHOOL STREET AND NORTH CHESTNUT STREET, AND FOR DESIGNATED SPACES IN THE BOROUGH'S PARKING LOT ADJACENT TO THE MUNICIPAL BUILDING, WHERE ALL SPACES ARE SOLELY TO BE USED FOR PURPOSES OF DROPPING CHILDREN OFF AT OR PICKING THEM UP FROM THE ELEMENTARY SCHOOL.

WHEREAS, the Borough of Avalon and the Parent Teacher Organization of Avalon Elementary (hereinafter, the "PTO"), both agree that the safety of the children attending Avalon Elementary is of paramount concern;

WHEREAS, the Borough of Avalon and the PTO believe that providing permit parking spaces with convenient access to Avalon Elementary will promote the safety of the children attending this school;

WHEREAS, the Borough of Avalon and the PTO agree that providing permit parking spaces with convenient access to Avalon Elementary will greatly assist persons dropping off or picking up children from Avalon Elementary;

WHEREAS, the Borough of Avalon has agreed to designate specific parking spaces for this purpose; and

WHEREAS, the PTO has agreed to advertise in *The Citizen*, the School Newsletter, and on the School's Web Site that Parking Permits may be purchased at Avalon Elementary through the PTO, at a cost of five dollars and no cents (\$5.00) per permit, with the costs of these permits to be shared 50/50 between the PTO and the Borough.

NOW, THEREFORE, BE IT RESOLVED in order to further the purpose set forth by this Resolution, the Borough of Avalon herein declares as follows:

SECTION 1. Beginning on September 7, 2010 and ending on June 8, 2011, designated permit parking spaces will be made available between North School Street and North Chestnut Street, and in designated spaces in the Borough's parking lot, adjacent to the Municipal Building, Monday through Friday, between the hours of 7:30 a.m. and 8:30


a.m. and 2:30 p.m. and 4:00 p.m. These parking spaces are to be used only by those persons who have a designated parking permit visibly attached to the rearview mirror of the vehicle parked in the designated space. Any vehicle parked in the designated space without the parking permit attached to the rearview mirror is considered as illegally parked.

SECTION 2. The PTO is hereby authorized to prepare an Application form to be completed by persons who have either a child, grandchild, and/or a child over whom the Applicant has legal custody attending Avalon Elementary. The Application shall require the Applicant to disclose the make, model number, color, and license plate number of the vehicle for which the parking permit is sought.

SECTION 3. The PTO is to provide the Borough Office with a copy of all Applications for which permits were issued and will provide the Borough with a 50% share of the monies obtained for issuing each permit.


