Motion to approve Change Order #1(Final) for the S. Home Avenue Storm Sewer Project in the amount of \$10,435.99.

Motion to approve Release and Reimbursement Agreement whereby Columbia Gas (Columbia) agrees to reimburse Avalon Borough for restoration and paving costs for Columbia's pipeline upgrade project along S. Home Avenue, Howden Street, Jackman Avenue and Elizabeth Avenue.

Note: Total restoration and paving costs to Columbia Gas is \$56,354.00.

Motion to approve Resolution #1320, a resolution to apply for a Local Share Assessment (LSA) grant in the amount of \$442,700 from the Commonwealth Finance Authority to be used for repairing the N. Birmingham Avenue retaining wall.

Motion to approve Resolution #1322, a resolution to apply for a Local Share Assessment (LSA) grant in the amount of \$100,000 from the Commonwealth Finance Authority to be used to replace the Avalon Borough Public Works and VFD Emergency Generator.

Motion to accept ALCOSAN GROW Grant Agreement to address Phase II Consent Order Source Flow Reduction Project in the amount of \$89,200.

Note: Total project cost estimated at \$534,900. A grant application has been submitted to GEDTF for \$500,000 for additional funding.

Motion to accept the bid proposal from Insight Pipe Contracting LLC for the 2023 Sanitary Sewer operation and Maintenance Repairs as follows: Base Bid for Sanitary O&M Repairs in the amount of \$209,245 and Add Alternate #1 for Storm Sewer Lining in the amount of \$45,200.

Note: Project partially funded by the PA Small Water and Sewer Grant received in the amount of \$151,283 with a 15% match by Avalon Borough.

Borough Development (Property, Planning, Parks)

Motion to approve Resolution #1321, a resolution to apply for a Local Share Assessment (LSA) grant in the amount of \$450,000 from the Commonwealth Finance Authority to be used for improvements to the Avalon Swimming Pool.

Motion to approve Ordinance #1404, an ordinance amending Ordinance #1327, Section 2000-403 of the Avalon-Bellevue-Ben Avon Joint Zoning Map, changing the zoning district designation of Lot/Blocks 160-F-323 and 160-F-326 from High Density Residential (R-H) to Mixed Use (MU).
